1. Applicability

This Privacy Policy applies to German School students, parents and/or guardians (“You,” “Your”).

2. Collection of Personal data

We collect a range of personal information from students, parents/guardians and their relatives/friends/neighbours and family doctors. For students, this includes their name, date of birth, class or grade and health information. For parents or guardians, we collect their name, contact details. We also collect friends, relative or neighbours details such as name, relationship to the child and their contact details and the family doctor’s name and contact details. In addition, we collect identification information including CCTV records when parents, students or their relatives, friends and neighbours access the School’s premises.

In most cases this information is collected directly from the parent or student. However, in some cases, the information may be collected indirectly

e.g., from CCTV cameras or from parents/guardians in relation to their friends/relatives/neighbours and family doctor(s)’ information.

3. Personal Data Uses

The personal information collected from students, parents/guardians, friends, neighbours and relatives and family doctor (s) serves specific purposes within our operations. For students, we utilise their name, date of birth, class or grade and health information to help us manage their health needs while at the School. For parents or guardians, their names, contact details are used to maintain communication and manage school records. For relatives/friends/neighbors and family doctor(s) their names and contact details are collected in cases of an emergency when we are not able to reach students’ parents/guardians.

4. Lawful Bases for Processing

The processing of the collected information is carried out on various legal bases. For students, the processing is based on consent and to protect their vital interests. When it comes to parents or guardians, the processing is based on legitimate interests, such as maintaining effective communication and ensuring efficient administrative operations. In relation to friends/neighbours/relatives and family doctor(s), the processing is based on legitimate interests such as communication in cases of emergency.

5. Your rights

You have certain rights over your personal data. You have the right to be informed about how your data is used, access your information, and request cor-

rections, erasure, or restriction of data processing. You can also object to the processing of your data and receive it in a portable format.

You have the right to withdraw your consent and rights related to automated

6. International Data Transfer.

In certain instances, we may transfer personal data internationally. This may include our cloud service providers who may have servers located outside Kenya, resulting in data transfers. We have implemented adequate security safeguards to protect your personal data during such transfers.

7. Personal Data Retention

We do not retain personal data indefinitely. We have established processes to determine the appropriate retention period for personal data in accordance with legal requirements. Once the purpose for which the data was collected has been fulfilled and there is no legal obligation to retain it, we securely dispose of personal data.

8. Your Responsibilities

It is your responsibility to provide accurate and up-to-date information when required, as this enables us to effectively process and manage your data. You should also notify us promptly of any changes or inaccuracies in your personal information. It is also your responsibility to inform individuals whose information you have provided such as relatives/friends/neighbours and family doctor(s) how we

collect, use, and protect their information.

9. Changes to this Policy

We reserve the right to modify this Privacy Policy as necessary. Any changes made to the policy will be communicated effectively, such as through our website or other appropriate channels, to keep you informed about how we collect, use, and protect your personal information. Your continued use of our services after the implementation of any modifications signifies your acceptance of the revised Privacy Policy
